Clause 20.1 of FIDIC Red, Yellow and Silver Books is in the same terms and provides that if the Contractor considers it is entitled to an extension of time and/or any additional payment, it is required to give notice "describing the event or circumstance giving rise to the claim as soon as practicable, and not later than 28 days after the Contractor became aware, or should have become aware, of the event or circumstances".

Particular features of the Yellow Book One of the main features under the FIDIC Yellow Book is the one of the role of the Engineer, as the Employer's Agent under this form of Contract, in respect of design reviews, which is limited to reviewing Design and Construction Drawings prepared and submitted by the Design-Build Contractor for the sole purpose of ascertaining that the information set forth therein generally conforms with the stated Employer's Requirements for the Design and the Works.

Clause 5.2 of the Yellow and Silver Books provides that the Contractor's documents shall comprise the technical documents specified in the Employer's Requirements, documents required to satisfy all regulatory approvals, the as-built documents described in clause 5.6 and the operation and maintenance manuals referred to in clause 5.7.
